- **2.** If the facility is not a legal entity, a letter of the support demonstrating commitment of the institution (legal entity) hosting the facility.
- **3.** A statement about acceptance of CERIC's user policy as defined in Article 8 of CERIC statutes and procedures, aligned with the <u>European Charter of access to Research Infrastructures</u>.
- **4.** A statement committing to make data available in a maximum period of 3 years.

The application will be assessed by the CERIC's Board of Directors (BoD) and International and Technical Advisory Committee (ISTAC). Following the successful evaluation, CERIC, the applicant and the legal representative endorsing the application will proceed to an agreement.

Data protection:

The gathered data will be used only for the processing and evaluation of the application by the BoD, ISTAC and the involved CERIC staff. All application data will be held securely according to the CERIC Personal Data Policy.
